*Polio - Fourth dose not needed if dose #3 given after 4th B-day and 6 months from previous dose

*Hib - last dose must be on or after 12 months of age-not required at age 5 years and older; number of total doses (3 or 4) depends on brand used

*PCV - last dose must be on or after 12 months of age-not required at age 5 years and older

*Varicella - no doses needed if history of Chickenpox or Zoster disease is verified by a medical provider

*Hepatitis A – 2 doses spaced 6 months apart- effective for the school year beginning on or after **July 1, 2018**
